Highlights of activities

KazAID initiatives focus on economic relations, digital economy, and environmental cooperation with international partners, including the UN.

- **"Dostyk: Digitalization" Programme:** Trained Central Asian civil servants in digital governance with the Technical Cooperation Directorate under the Ministry of Foreign Affairs of Singapore.
- **"Dostyk: Diplomacy" Programme:** Trained the representatives from MFA Central Asia on water diplomacy with the Academy of Public Administration under the President of Kazakhstan.
- **"Avicenna: Healthcare" Programme:** Support academic mobility of the youth and capacity building of the teaching staff from Central Asian countries in collaboration with TIKA.
- **Seismic Insulation Seminar:** Hosted with JICA for specialists from Central Asia and the Caucasus.
- **Paris Agreement Seminar:** Collaborated with AIDA, UNEP, and UNFCCC for transparency reporting in Astana for 15 developing countries.
- **Kaizen Seminar:** Introduces Kaizen practices to improve business efficiency annually with JICA.
